## Recycle Your Shrink Wrap



Thanks to a grant from *I BOAT NJ*, the NJDEP Coastal Management Office awarded funding to 9 counties in New Jersey creating 30 options/locations for shrink wrap disposal throughout the state. The New Jersey Sea Grant Extension Program has created fact sheets containing information about how to prepare shrink wrap for recycling and information on disposal options for both marina owners and boaters. Also available to marinas is a 12" x 18" shrink wrap recycling poster. To receive a poster and/or PDFs of the fact sheets for distribution, see the box on the reverse side.

In order for this collection effort to be successful, please adhere to the following guidelines:

- Keep shrink wrap as **DRY** and as **CLEAN** as possible.
- Remove zippers, vents and nylon strips.
- Roll shrink wrap into a small bundle.

Locations for shrink wrap disposal are now available in the following towns:

- **Sussex County** - Lafayette, Ogdensburg
- **Union County** - Elizabeth

### Recycle It!

#### Shrink Wrap

To prep for recycling, remove doors, zippers, vents, etc. and other non-shrink wrap materials and roll into a 4" - 5" wide bundle, keeping it free from dirt and other debris.

#### Zinc (Sacrificial Anodes)

Check with your town recycling center or marine supply business for disposal options.

#### Mercury-Containing Devices

(Blige Float Switches)  
Dispose as household hazardous waste on the appropriate collection day.

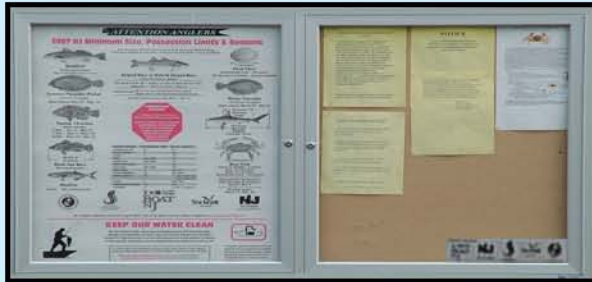

## Outdoor Marina Display Case

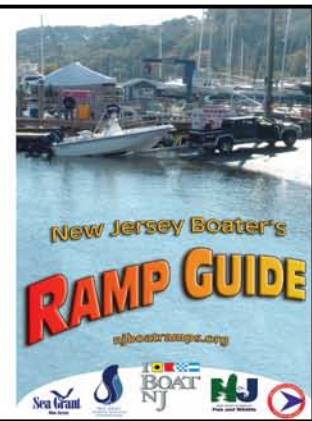
The New Jersey Sea Grant Extension Program and *I*BOAT NJ are continuing the marina display case project for 2008. A FREE display case (5 ft x 3 ft) will be given to marinas and boat ramps willing to: 1) place, update and maintain the display case in a high traffic area frequented by boaters and fishermen; 2) post the current marine recreational fishing regulations annually (large format provided); and 3) post boating/marina related materials in the other panel.

2008 Fish Regulation Cards and Posters will be available by mid-April. To receive copies of the regulation cards see the box below. Posters will be mailed or delivered to the marinas participating in the display case program.

## Monofilament Fishing Line Recycling Program

The New Jersey Coastal Management Program is partnering with BoatU.S. Foundation and the BoatU.S. Angler Program to collect and recycle monofilament fishing line. To date, 15 collection bins (made of sturdy PVC pipe) and signs have been distributed to various locations. When the bins are full, the host facility will ship the line in postage paid boxes, to Berkeley Conservation for recycling.

Collection bins are distributed on a first-come, first-serve basis with some priority on expanding the geographic range of the bins.
