NJCMP Receives Funding

The New Jersey Clean Marina Program has received over \$400,000 in new funding from the *I BOAT NJ* Program. Over the next two years, NJCMP will use the new funds to increase program participation among marinas and other boating businesses as well as provide outreach and technical guidance to marinas interested in adopting BMPs. The new grant will also fund smaller projects, allowing marina owners to apply for funding to implement BMPs at their facilities.

MTA/NJ UNVEILS RESULTS OF RECREATIONAL BOATING ECONOMIC IMPACT STUDY

The Marine Trades Association of New Jersey (MTA/NJ) unveiled the results of a two year effort to quantify the economic impacts of recreational boating in the State of New Jersey at the Association's Annual Dinner & Elections. This study, the first of its kind in New Jersey, directly measured expenditures related to recreational boating and their impact on the state's economy.

The survey results indicate that New Jersey boaters spent approximately \$2.1 billion dollars on in-state recreational boating activities in 2006. Of the money spent, \$1.1 billion were trip-related expenditures and \$938 million were in annual boating purchases (such as registration fees, maintenance, etc.). The study also showed that New Jersey's recreational boating industry provides approximately 18,000 jobs.

Regulatory Air Permit Reminder

An air permit (N.J.A.C. 7:27) is required if a marina dispenses gasoline or other volatile fuel products from an aboveground or underground storage tank greater than 2,000 gallons in capacity. An air permit is also required if the marina uses equipment in a surface coating operation such as spray painting in which the quantity of coating or cleaning material used in any one hour is equal or greater than on half gallon of liquid.

CVA Offering Operation and Maintenance Funding for Marinas with Pumpouts

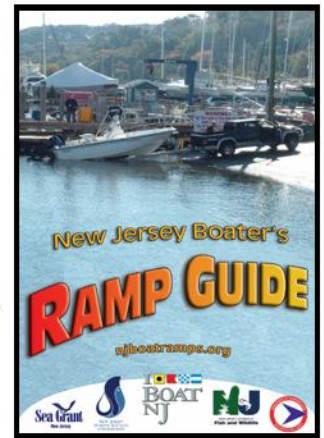
The New Jersey Clean Vessel Act Program is pleased to announce the availability of Operation and Maintenance (O&M) funding to New Jersey marinas. Up to \$1,500 in expenses will be reimbursed per marina for the O & M of pumpout equipment during the 2008 boating season. Marinas can be reimbursed for pumpout staff costs, repairs, maintenance, and boat sewage hauling fees, less any income generated from fees charged for pumpout service.

GOING GREEN FOR 2008

In an effort to protect the environment, many people are adopting "green" practices in their everyday lives. There are many ways to also incorporate these practices in the boating industry. Today there are many new environmentally friendly products on the market to replace harsh chemicals, cleaners, paints and paint strippers. Not only are they healthier for the environment, but for the user as well.

Remember to recycle:


- Plastic and glass bottles
- Cans
- Monofilament fishing line
- Cardboard
- Paper
- Oil
- Computers/electronics
- Batteries
- Antifreeze
- Vessel wash water
- Zinc and aluminum anodes and other scrap metals
- Shrink wrap
- Mercury containing devices, i.e. bilge float switches, thermostats

A few ways to conserve energy:

- Replace incandescent bulbs with compact fluorescent bulbs which use less energy and last longer than traditional light bulbs.
- Use motion sensors for lights in low traffic areas such as restrooms, store rooms, etc.
- Use hand dryers in restrooms instead of paper towels reducing waste and cost of supplies.
