#### Vessel Wash Wastewater

Marinas must eliminate the discharge of vessel wash waste water into surface and ground water by May 31, 2009. Marinas have the option of ceasing the practice of washing vessels or can capture the water and recycle the waste water, haul it away for proper disposal or request permission to connect to the sanitary sewer where applicable.

#### Permit By Rule Adopted

The NJDEP rules for constructing and/or installing the infrastructure necessary to comply with the Basic Industrial Stormwater General Permit have been revised. This revision provides guidelines for marinas to follow that will preclude the need for a State permit. It may still be necessary, however, to obtain local permits.

#### Winter Flounder Spawning Habitat Study Update Management measures to minimize impacts to spawning


winter flounder and the resulting fertilized eggs have resulted in narrow dredging windows that limit dredging necessary to maintain adequate water depth in marina basins and other waterways. Spawning habitat is currently defined as "strictly estuarine" which often prevents winter-spring dredging from being permitted. Research results indicate that winter flounder movements are variable, and spawning may take place in estuaries as well as on the continental shelf.

A research effort to account for these variations is currently being conducted by researchers from the Rutgers Institute of Marine and Coastal Sciences in the Navesink River, negat Bay - Great Bay, and on the inner continental shelf. The I BOAT NJ Program and NJ Sea Grant Program are providing funds for the effort. For more information and updates on the status of the project

### **AMI Action Alert**

A marina operator, whose diesel fuel pumps were recently inspected by a local U.S. IRS inspector, was fined over \$27,000 for not having the proper labels (decals) posted on their pumps. The fine was \$10 for each gallon of diesel fuel in the storage tank. They could have been fined \$10 for each gallon of diesel fuel SOLD over the entire period that the pumps were not properly labeled, which could have totaled over \$1,000,000!

Although they had a label on the pump indicating the fuel was dyed and FOR OFF HIGHWAY USE ONLY, which complies with EPA requirements, the IRS regulation 48.4082-2 also requires a label that indicates dyed diesel is TAX EXEMPT AND PENALTY FOR TAXABLE USE.

There are companies that sell these labels ready-made or you can have them made for each of your fuel pumps. Be prepared and avoid possible hefty fines.

## NJDEP Environmental Steward Program

Congratulations to Main One Marina for the recent recognition of its environmental stewardship activities.

In January 2008, the NJDEP initiated a program to highlight environmental stewardship to encourage businesses and other institutions to better protect the environment by exceeding regulatory requirements. Approximately 80 facilities have been verified and recognized including marinas, manufacturers, chemical and pharmaceutical companies, government agencies, utilities authorities, medical facilities and educational institutions. The intent is to showcase the achievements of members of the regulated community and serve as an information resource to encourage others to follow. If your marina has been designated as a Clean Marina you may already qualify for the Environmental Stewardship Program.

Verification visits for the Program will be conducted by DEP Inspectors during inspection visits. When visited by an inspector mention that you are Clean Marina and would like be nominated for the Environmental Stewardship Program. The inspector may, at their discretion, nominate your marina for recognition.
